## **CULTURAL ARTS COUNCIL CLASSES, WORKSHOPS AND CAMPS POLICIES**

**FEES:** All fees are non-refundable and non-transferable. CAC does not pro-rate classes, workshops, and art camps.

**CANCELLATIONS:** If a class or program has to be cancelled by the CAC, you will be notified as soon as possible and a make-up session will be scheduled. If a student cannot attend a class no make-up session is offered.

**STUDENT BEHAVIOR POLICY:** CAC reserves the right to cancel, with no refund, the registration of a student, if participation by the student is deemed disruptive or interferes with the learning atmosphere of the class/workshop.
